**ORDER**

WHEREAS, in exercise of the powers conferred by Sub-section (2) of Section 12 of the National Council for Teacher Education Act, 1993 (7) of 1993) and in supersession of the National Council for Teacher Education (Recognition, Status and Procedure) Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 17.12.2014.

AND, WHEREAS, the recognition has been granted to the institutions mentioned in para 5 below for the course mentioned against their name.

AND, WHEREAS, the said institutions by affidavit have consented to come under New Regulations and have sought for the number of units in B.Ed./B.P.Ed/M.Ed. as mentioned in para 5 below against their name, which may require additional facilities.

AND, WHEREAS, it has been decided to permit the institution to have the desired number of units subject to fulfilling the following conditions:

- (i) The institution shall create additional facilities that include (a) additional faculty/staff, (b) additional infrastructure, (c) additional funds, (d) adhere to staff norms as per Regulations, 2014 and various Regional Committees with required documents by October 31, 2015.
- (ii) The applicant institution for additional unit will be required to submit the required documents, such as, land documents, Non-Encumbrance Certificate (EC), Change of Land Use Certificate (CLU) and Building Plan (BP) in the specified proforma available on the website of the Regional Committee in case of having provided the additional facilities before October 31, 2015. Building completion Certificate (BCC) may be given along with other documents if available, otherwise it can be given in the Visiting Form at the time of inspection.
- (iii) The Regional Committee shall arrange for verification of documents, inspection of the premises and check adherence to these conditions by 20 February, 2016. If it is found by the Regional Committee that the institution has failed to comply with these requirements, the institution shall not be permitted to admit students for the academic year 2016-2017.
- (iv) In case any existing institution's matter is sub-judice under court direction/CM order/section 17 of the NCTE Act/Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/apply to SC/Complaint already submitted alongwith documents, if any, together with the documents referred above. In case the institution's request for shifting of premises is pending, such institutions shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affording body/State Govt. and such other documents as indicated in the revised format recognition order. This order shall be subject to the directions given by the Hon'ble Court in the Writ Petition and in respect of Section 17 compliance cases etc. as decided by the Northern Regional Committee.

Now, therefore, in light of the above, the Northern Regional Committee, NCTE hereby issues the revised Recognition Order to the following institutions for conducting the under mentioned programme/course of units subject to duration from the academic session 2015-2016 subject to fulfillment of the conditions before 31.10.2015 mentioned in para 5 above:

6. This revised order will be treated as cancelled in respect of those cases where recognition of the institutions has been withdrawn by NRC, NCTE.

7. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by the regulatory bodies like UGC, affiliating University/Body, State Government etc. as applicable. The affiliating body (University/State Govt.) shall also be required to verify the authenticity of the land & building documents with appointment of requisite teaching & non-teaching staff as per provisions of the NCTE Regulations, 2006 by concerned institutions before grant of affiliation to an institution.

8. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with statement of annual accounts duly audited by a Chartered Accountant.

9. The institution shall maintain & update its website as per provisions of NCTE regulations and also display the following mandatory disclosures:

- (i) Sanctioned programme(s) along with annual intake in the institution.
- (ii) Details of the faculty and staff as mentioned in school certificate along with their qualifications.
- (iii) Names of faculty members who left or joined during the last quarter.
- (iv) Names of students admitted during the current session along with qualification, percentage marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
- (v) Fee charged from students.
- (vi) Available infrastructural facilities.

- (c) Facilities added during the last quarter.
- (d) Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- (e) The affidavit with enclosures submitted along with application.
- (f) The institution shall be free to post additional information, if it so desires.

10. Any false or incomplete information on the website of the institution shall render the institution liable for withdrawal of recognition.

11. In the event of non-observance of the above conditions or the provision of the NCTE Act, Rules, Regulations and Orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act.
